# Introduction

NN Group N.V. (NN Group) reports on its application of the Dutch Corporate Governance Code (the Code) in its booklet over the financial year 2023.

As a Dutch listed company NN Group must adhere to the Code. NN Group endorses the Code and strongly supports its principles for sound and responsible corporate governance. NN Group considers the principles and best practices of the Code a useful and efficient guide that contributes to NN Group's effort to carefully take into account the interests of its stakeholders. The Code also supports transparency in decision-making and helps strengthen the principles of good governance.

It should be noted in this respect that NN Group has an executive board (the Executive Board) and a management board (the Management Board). The Executive Board is the board as defined in the law and is entrusted with the management, the strategy and the operations of NN Group under the supervision of the supervisory board of NN Group (the Supervisory Board). The Executive Board may perform all acts necessary or useful for achieving NN Group's corporate purpose, except for those expressly attributed to the general meeting of NN Group (the General Meeting) or the Supervisory Board as a matter of Dutch law or pursuant to the articles of association of NN Group. The Management Board is entrusted with the day-to-day management of NN Group and the overall strategic direction of NN Group. Any reference in the Code to the 'management board' should be interpreted as a reference to the Executive Board.

It is the responsibility of both the Executive Board and the Supervisory Board to monitor NN Group's overall corporate governance structure. Any substantial change to this structure shall be submitted to the General Meeting for discussion. NN Group complies with the principles and the best practice provisions of the Code and, if applicable, explains why and to what extent it deviates from them. In this booklet NN Group clarifies where appropriate how the principles and best practice provisions are implemented in NN Group's corporate governance.

# 1. Sustainable long-term value creation

## Principle

## Implementation by NN Group

<b>1.1</b>	<b>Sustainable long-term value creation</b> <p>The management board is responsible for the continuity of the company and its affiliated enterprise and for sustainable long-term value creation by the company and its affiliated enterprise. The management board takes into account the impact the actions of the company and its affiliated enterprise have on people and the environment and to that end weighs the stakeholder interests that are relevant in this context. The supervisory board monitors the management board in this regard.</p>	NN Group applies this principle.

## Best practice provisions

<b>1.1.1</b>	<b>Strategy for sustainable long-term value creation</b> <p>The management board should develop a view on sustainable long-term value creation by the company and its affiliated enterprise and formulate a strategy in line with this. The management board should formulate specific objectives in this regard. Depending on market dynamics, it may be necessary to make short-term adjustments to the strategy.</p> <p>When developing the strategy, attention should in any event be paid to the following:</p> <ol style="list-style-type: none"><li>i. the strategy's implementation and feasibility;</li><li>ii. the business model applied by the company and the market in which the company and its affiliated enterprise operate;</li><li>iii. opportunities and risks for the company;</li><li>iv. the company's operational and financial goals and their impact on its future position in relevant markets;</li><li>v. the interests of the stakeholders;</li><li>vi. the impact of the company and its affiliated enterprise in the field of sustainability, including the effects on people and the environment;</li><li>vii. paying a fair share of tax to the countries in which the company operates; and</li><li>viii. the impact of new technologies and changing business models.</li></ol>	NN Group applies this best practice provision.

<b>1.1.2</b>	<b>Involvement of the supervisory board</b>	<p>The management board should engage the supervisory board early on in formulating the strategy for realising sustainable long-term value creation. The management board accounts to the supervisory board for the strategy and the explanatory notes to that strategy.</p>	<p>NN Group applies this best practice provision.</p>
<b>1.1.3</b>	<b>Role of the Supervisory Board</b>	<p>The supervisory board should supervise the manner in which the management board implements the strategy for sustainable long-term value creation. The supervisory board should regularly discuss the strategy, the implementation of the strategy and the principal risks associated with it. In the report drawn up by the supervisory board, an account is given of its involvement in the establishment of the strategy, and the way in which it monitors its implementation.</p>	<p>NN Group applies this best practice provision.</p>
<b>1.1.4</b>	<b>Reporting by the management board</b>	<p>In the management report, the management board should provide a more detailed explanation of its view on sustainable long-term value creation and the strategy to realise this and describe the contributions made to sustainable long-term value creation in the past financial year. In addition, it describes the formulated objectives, what effects the company's products, services and activities have had on people and the environment, how the interests of stakeholders have been considered, what action has been taken in that context and the extent to which the set objectives have been attained. The management board should report on both short- and the long-term developments.</p> <p>The second sentence of this best practice provision is not applicable if the company reports in accordance with the requirements laid down in Dutch legislation pursuant to the Corporate Sustainability Reporting Directive (CSRD) or comparable or comparable standards applicable to the company in respect of its listing outside the Netherlands.</p>	<p>NN Group applies this best practice provision.</p>
<b>1.1.5</b>	<b>Dialogue with stakeholders</b>	<p>To ensure that the interests of the relevant stakeholders of the company are considered when the sustainability aspects of the strategy are determined, the company should draw up an outline policy for effective dialogue with those stakeholders. The relevant stakeholders and the company should be prepared to engage in a dialogue. The company should facilitate this dialogue unless, in the opinion of the management board, this is not in the interests of the company and its affiliated enterprise. The company should publish the policy on its website.</p>	<p>NN Group applies this principle.</p>

## Implementation by NN Group

<b>1.2</b>	<b>Risk Management</b> <p>The company should have adequate internal risk management and control systems in place. The management board is responsible for identifying and managing the risks associated with the company's strategy and activities.</p>	NN Group applies this principle.

## Best practice provisions

<b>1.2.1</b>	<b>Risk assessment</b> <p>The management board should identify and analyse the risks associated with the strategy and activities of the company and its affiliated enterprise. The identification and analysis should cover in any case the strategic, operational, compliance and reporting risks. The management board is responsible for establishing the risk appetite, and also the measures that are put in place in order to counter the risks being taken.</p>	NN Group applies this best practice provision.
<b>1.2.2</b>	<b>Implementation</b> <p>Based on the risk assessment, as referred to in best practice provision 1.2.1, the management board should design, implement and maintain adequate internal risk management and control systems. To the extent relevant, these systems should be integrated into the work processes within the company and its affiliated enterprise, and should be familiar to those whose work they are relevant to.</p>	NN Group applies this best practice provision.
<b>1.2.3</b>	<b>Monitoring of design and operation</b> <p>The management board should monitor the design and operation of the internal risk management and control systems and should carry out a systematic assessment of their design and operation at least once a year. Attention should be paid to observed weaknesses, instances of misconduct and irregularities, indications from whistleblowers, lessons learned and findings from the internal audit function and the external auditor. Where necessary, improvements should be made to internal risk management and control systems.</p>	NN Group applies this best practice provision.

## Implementation by NN Group

<b>1.3</b>	<b>Internal audit function</b> <p>The task of the internal audit function is to assess the design and operation of the internal risk management and control systems. The management board is responsible for the internal audit function. The supervisory board oversees the internal audit function and maintains regular contact with the person fulfilling this function.</p>	NN Group applies this principle.

## Best practice provisions

<b>1.3.1</b>	<b>Appointment and dismissal</b> <p>The management board both appoints and dismisses the senior internal auditor. Both the appointment and the dismissal of the senior internal auditor should be submitted to the supervisory board for approval, along with the recommendation of the audit committee.</p>	NN Group applies this best practice provision.
<b>1.3.2</b>	<b>Assessment of the internal audit function</b> <p>The management board should assess annually the way in which the internal audit function fulfils its responsibility, after consultation with the audit committee. An independent third party should assess the performance of the internal audit function at least every five years.</p>	NN Group applies this best practice provision.
<b>1.3.3</b>	<b>Internal audit plan</b> <p>The internal audit function should draw up an audit plan after consultation with the management board, the audit committee and the external auditor. The audit plan should be submitted to the management board and then to the supervisory board for approval. In the internal audit plan, attention should be paid to interaction with the external auditor.</p>	NN Group applies this best practice provision.
<b>1.3.4</b>	<b>Performance of work</b> <p>The internal audit function should have sufficient resources to execute the internal audit plan and have access to information that is important for the performance of its work. The internal audit function should have direct access to the audit committee and the external auditor. Records should be kept of how the audit committee is informed by the internal audit function.</p>	NN Group applies this best practice provision.



### 1.3.5

#### **Report of findings**

The internal audit function should report the audit results to the management board and the audit committee, and inform the external auditor. The findings of the internal audit function should, at least, include the following:

- i. any flaws in the effectiveness of the internal risk management and control systems;
- ii. any findings and observations with a material impact on the risk profile of the company and its affiliated enterprise; and
- iii. any failings in the follow-up of recommendations made by the internal audit function.

The internal audit function should report hierarchically to a member of the management board, preferably to the CEO.

NN Group applies this best practice provision.

### 1.3.6

#### **Absence of an internal audit department**

If there is no separate department for the internal audit function, the supervisory board will assess annually whether adequate alternative measures have been taken, partly on the basis of a recommendation issued by the audit committee, and will consider whether it is necessary to establish an internal audit department. The supervisory board should include the conclusions, along with any resulting recommendations and alternative measures, in the report of the supervisory board.

This best practice provision is not relevant for NN Group as NN Group has an internal audit department.

<b>1.4</b>	<b>Risk management accountability</b> The management board should render account of the effectiveness of the design and the operation of the internal risk management and control systems.	NN Group applies this principle.

## Best practice provisions

<b>1.4.1</b>	<b>Accountability to the supervisory board</b> The management board should discuss the effectiveness of the design and operation of the internal risk management and control systems referred to in best practice provisions 1.2.1 to 1.2.3 inclusive with the audit committee, and render account of this to the supervisory board.	NN Group applies this best practice provision.
<b>1.4.2</b>	<b>Reporting on risk management</b> In the management report, the management board should render account of: <ul style="list-style-type: none"><li>i. the execution of the risk assessment, with a description of the principal risks facing the company in relation to its risk appetite, as referred to in best practice provision 1.2.1;</li><li>ii. the design and operation of the internal risk management and control systems during the past financial year;</li><li>iii. any major failings in the internal risk management and control systems which have been observed in the financial year, any significant changes made to these systems and any major improvements planned, along with a confirmation that these issues have been discussed with the audit committee and the supervisory board; and</li><li>iv. the sensitivity of the results of the company to material changes in external factors.</li></ul>	NN Group applies this best practice provision.
<b>1.4.3</b>	<b>Statement by the management board</b> The management board should state in the management report, with clear substantiation, that: <ul style="list-style-type: none"><li>i. the report provides sufficient insights into any failings in the effectiveness of the internal risk management and control systems with regard to the risks as referred to in best practice provision 1.2.1;</li><li>ii. the aforementioned systems provide reasonable assurance that the financial reporting does not contain any material inaccuracies;</li><li>iii. based on the current state of affairs, it is justified that the financial reporting is prepared on a going concern basis; and</li><li>iv. the report states the material risks, as referred to in best practice provision 1.2.1, and the uncertainties, to the extent that they are relevant to the expectation of the company's continuity for the period of twelve months after the preparation of the report.</li></ul>	NN Group applies this best practice provision.

## Principle

## Implementation by NN Group

<b>1.5</b>	<b>Role of the supervisory board</b> <p>The supervisory board should supervise the policies carried out by the management board and the general affairs of the company and its affiliated enterprise. In so doing, the supervisory board should also focus on the effectiveness of the company's internal risk management and control systems and the integrity and quality of the financial and sustainability reporting.</p>	NN Group applies this principle.

## Best practice provisions

<b>1.5.1</b>	<b>Duties and responsibilities of the audit committee</b> <p>The audit committee undertakes preparatory work for the supervisory board's decision-making regarding the supervision of the integrity and quality of the company's financial and sustainability reporting and the effectiveness of the company's internal risk management and control systems, as referred to in best practice provisions 1.2.1 to 1.2.3 inclusive. It focuses among other things on the supervision of the management board with regard to:</p> <ol style="list-style-type: none"><li>relations with, and compliance with, recommendations and follow-up of comments by the internal and external auditors and any other external party involved in auditing the sustainability reporting;</li><li>the funding of the company; and</li><li>the company's tax policy.</li></ol>	NN Group applies this best practice provision.
<b>1.5.2</b>	<b>Attendance of the management board, internal auditor and external auditor at audit committee consultations</b> <p>The chief financial officer, the internal auditor and the external auditor should attend the audit committee meetings, unless the audit committee determines otherwise. The audit committee should decide whether and, if so, when the chairman of the management board should attend its meetings.</p>	NN Group applies this best practice provision.
<b>1.5.3</b>	<b>Audit committee report</b> <p>The audit committee should report to the supervisory board on its deliberations and findings. This report must, at least, include the following information:</p> <ol style="list-style-type: none"><li>the methods used to assess the effectiveness of the design and operation of the internal risk management and control systems referred to in best practice provisions 1.2.1 to 1.2.3 inclusive;</li><li>the methods used to assess the effectiveness of the internal and external audit processes;</li><li>material considerations concerning financial and sustainability reporting; and</li><li>the way in which the material risks and uncertainties, referred to in best practice provisions 1.4.2 and 1.4.3, have been analysed and discussed, along with a description of the most important findings of the audit committee.</li></ol>	NN Group applies this best practice provision.

##### **Supervisory board**

The supervisory board should discuss the items reported on by the audit committee on the basis of best practice provision 1.5.3.

<b>1.6</b>	<b>Appointment and assessment of the functioning of the external auditor</b>  The supervisory board should submit the nomination for the appointment of the external auditor to the general meeting, and should supervise the external auditor's functioning.	NN Group applies this principle.

## Best practice provisions

<b>1.6.1</b>	<b>Functioning and appointment</b>  The audit committee should report annually to the supervisory board on the functioning of, and the developments in, the relationship with the external auditor. The audit committee should advise the supervisory board regarding the external auditor's nomination for appointment/reappointment or dismissal and should prepare the selection of the external auditor. The audit committee should give due consideration to the management board's observations during the aforementioned work. Also on this basis, the supervisory board should determine its nomination for the appointment of the external auditor to the general meeting.	NN Group applies this best practice provision.
<b>1.6.2</b>	<b>Informing the external auditor about their functioning</b>  The supervisory board should give the external auditor a general idea of the content of the reports relating to their functioning.	NN Group applies this best practice provision.
<b>1.6.3</b>	<b>Engagement</b>  The audit committee should submit a proposal to the supervisory board for the external auditor's engagement to audit the annual accounts. The management board should play a facilitating role in this process. In formulating the terms of engagement, attention should be paid to the scope of the audit, the materiality to be applied and remuneration for the audit. The supervisory board should resolve on the engagement.	NN Group applies this best practice provision.
<b>1.6.4</b>	<b>Accountability</b>  The main conclusions of the supervisory board regarding the external auditor's nomination and the outcomes of the external auditor selection process should be communicated to the general meeting.	NN Group applies this best practice provision.
<b>1.6.5</b>	<b>Departure of the external auditor</b>  The company should publish a press release in the event of the early termination of the relationship with the external audit firm. The press release should explain the reasons for this early termination.	NN Group shall apply this best practice provision.

<b>1.7</b>	<b>Performance of the external auditor's work</b> <p>The audit committee and the external auditor should discuss the audit plan and the findings of the external auditor based on the work the external auditor has undertaken. The management board and the supervisory board should maintain regular contact with the external auditor.</p>	NN Group applies this principle.

## Best practice provisions

<b>1.7.1</b>	<b>Provision of information to the external auditor</b> <p>The management board should ensure that the external auditor will receive all information that is necessary for the performance of his work in a timely fashion. The management board should give the external auditor the opportunity to respond to the information that has been provided.</p>	NN Group applies this best practice provision.
<b>1.7.2</b>	<b>Audit plan and external auditor's findings</b> <p>The external auditor should discuss the draft audit plan with the management board before presenting it to the audit committee. The audit committee should discuss annually with the external auditor:</p> <ol style="list-style-type: none"><li>the scope and materiality of the audit plan and the principal risks of the annual reporting identified by the external auditor in the audit plan; and</li><li>based also on the documents from which the audit plan was developed, the findings and outcomes of the audit work on the annual accounts and the management letter.</li></ol>	NN Group applies this best practice provision.
<b>1.7.3</b>	<b>Publication of financial reports</b> <p>The audit committee should determine whether and, if so, how the external auditor should be involved in the content and publication of financial reports other than the annual accounts.</p>	NN Group applies this best practice provision.
<b>1.7.4</b>	<b>Consultations with the external auditor outside the management board's presence</b> <p>The audit committee should meet with the external auditor as often as it considers necessary, but at least once per year, without the presence of the management board.</p>	NN Group applies this best practice provision.
<b>1.7.5</b>	<b>Examination of discussion points arising between the external auditor and the management board</b> <p>The supervisory board should be permitted to examine the most important points of discussion arising between the external auditor and the management board based on the draft management letter or the draft audit report.</p>	NN Group applies this best practice provision.
<b>1.7.6</b>	<b>External auditor's attendance of supervisory board meetings</b> <p>The external auditor should in any event attend the meeting of the supervisory board at which the report of the external auditor on the audit of the annual accounts is discussed.</p>	NN Group applies this best practice provision.

## 2. Effective management and supervision

### Principle

### Implementation by NN Group

<b>2.1</b>	<b>Composition and size</b> <p>The management board, the supervisory board and the executive committee (if any) should be composed in such a way as to ensure a degree of diversity appropriate to the company with regard to expertise, experience, competencies, other personal qualities, sex or gender identity, age, nationality and cultural or other background.</p>	NN Group applies this principle.

### Best practice provisions

<b>2.1.1</b>	<b>Profile</b> <p>The supervisory board should prepare a profile, taking account of the nature and the activities of the enterprise affiliated with the company.</p> <p>The profile should address:</p> <ol style="list-style-type: none"><li>the desired expertise and background of the supervisory board members;</li><li>the desired diverse composition of the supervisory board, referred to in best practice provision 2.1.5;</li><li>the size of the supervisory board; and</li><li>the independence of the supervisory board members.</li></ol> <p>The profile should be posted on the company's website.</p>	NN Group applies this best practice provision.
<b>2.1.2</b>	<b>Personal information</b> <p>The following information about each supervisory board member should be included in the report of the supervisory board:</p> <ol style="list-style-type: none"><li>sex or, if desired by the person concerned, gender identity;</li><li>age;</li><li>nationality;</li><li>principal position (if appropriate);</li><li>other positions, insofar as they are relevant to the performance of the duties of the supervisory board member;</li><li>date of initial appointment; and</li><li>current term of office.</li></ol>	NN Group applies this best practice provision.

<b>2.1.3</b>	<p><b>Executive committee</b></p> <p>If the management board works with an executive committee, the management board should take account of the checks and balances that are part of the two-tier system. This means, among other things, that the management board’s expertise and responsibilities are safeguarded and the supervisory board is informed adequately. The supervisory board should supervise this while paying specific attention to the dynamics and the relationship between the management board and the executive committee.</p> <p>In the management report, account should be rendered of:</p> <ul style="list-style-type: none"> <li>i. the choice to work with an executive committee;</li> <li>ii. the role, duty and composition of the executive committee; and</li> <li>iii. how the contacts between the supervisory board and the executive committee have been given shape.</li> </ul>	<p>NN Group applies this best practice provision.</p>
<b>2.1.4</b>	<p><b>Expertise</b></p> <p>Each supervisory board member and each management board member should have the specific expertise required for the fulfilment of his duties. Each supervisory board member should be capable of assessing the broad outline of the overall management.</p>	<p>NN Group applies this best practice provision.</p>
<b>2.1.5</b>	<p><b>Policy on Diversity and Inclusion (D&amp;I policy)</b></p> <p>The company should have a D&amp;I policy for the enterprise. The D&amp;I policy should in any case set specific, appropriate and ambitious targets in order to achieve a good balance in gender diversity and the other D&amp;I aspects of relevance to the company with regard to the composition of the management board, the supervisory board, the executive committee (if any) and a category of employees in managerial positions (“senior management”) to be determined by the management board.</p> <p>The supervisory board adopt the D&amp;I policy for the composition of the management board and the supervisory board. The management board should adopt the D&amp;I policy for the executive committee (if applicable), the senior management and for the rest of the workforce with the prior approval of the supervisory board.</p>	<p>NN Group applies this best practice provision.</p>



### 2.1.6 Reporting on the D&I policy

The corporate governance statement should explain the D&I policy and the way in which it is implemented in practice. This includes the following information:

- i. the goals of the D&I policy;
- ii. the plan to achieve the goals of the D&I policy;
- iii. the results of the D&I policy in the past financial year and – where relevant and applicable – insight into the inflow, progression and retention of employees; and
- iv. the gender composition of the management board, the supervisory board, the executive committee (if any) and senior management at the end of the past financial year.

NN Group applies this best practice provision.

If one or more goals for the composition of the management board, the supervisory board, the executive committee (if any) and/or senior management are not achieved, an explanation of the reasons should be included in the corporate governance statement, along with an explanation as to which measures are being taken to attain the goals, and by when this is likely to be achieved.

### 2.1.7 Independence of the supervisory board

The composition of the supervisory board is such that the members are able to operate independently and critically vis-à-vis one another, the management board and any particular interests involved.

NN Group applies this best practice provision.

In order to safeguard its independence, the supervisory board is composed in accordance with the following criteria:

- i. any one of the criteria referred to in best practice provision 2.1.8, sections i to v inclusive, should be applicable to at most one supervisory board member;
- ii. the total number of supervisory board members to whom the criteria referred to in best practice provision 2.1.8 are applicable should account for less than half of the total number of supervisory board members; and
- iii. for each shareholder or group of affiliated shareholders directly or indirectly holding more than 10 per cent of the shares in the company, there is at most one supervisory board member who can be considered to be affiliated with or representing them as stipulated in best practice provision 2.1.8, sections vi and vii.

### 2.1.8 Independence of supervisory board members

Supervisory board members are not independent if they or their spouse, registered partner or life companion, foster child or relative by blood or marriage up to the second degree:

- i. has been an employee or member of the management board of the company or an issuing institution associated with the company as referred to in Section 5:48 of the Financial Supervision Act (Wet op het financieel toezicht, Wft) in the five years prior to the appointment;
- ii. receives personal financial compensation from the company, or an entity associated with it, other than the compensation received for the work performed as a supervisory board member and insofar as this is not in keeping with the normal course of business;
- iii. has had an important business relationship with the company or an entity associated with it in the year prior to the appointment. This includes in any event the case where the supervisory board member, or the form of which he is a shareholder, partner, associate or advisor, has acted as advisor to the company (consultant, external auditor, civil notary or lawyer) and the case where the supervisory board member has been a management board member or an employee of a bank with which the company has a lasting and significant relationship;
- iv. is a member of the management board of a company in which a member of the management board of the company which he supervises is a supervisory board member;
- v. has temporarily performed management duties during the previous twelve months in the absence or incapacity of management board members;
- vi. has a shareholding in the company of at least 10 per cent, taking into account the shareholding of natural persons or legal entities collaborating with him on the basis of an express or tacit verbal or written agreement;
- vii. is a member of the management board or supervisory board – or is a representative in some other way – of a legal entity which directly or indirectly holds at least 10 per cent of the shares in the company, unless the entity is a group company.

NN Group applies this best practice provision.

### 2.1.9 Independence of the chairman of the supervisory board

The chairman of the supervisory board should not be a former member of the management board of the company and should be independent within the meaning of best practice provision 2.1.8.

NN Group applies this best practice provision.

### 2.1.10 Accountability regarding supervisory board member independence

The report of the supervisory board should state that, in the opinion of the supervisory board, the independence requirements referred to in best practice provisions 2.1.7 to 2.1.9 inclusive have been fulfilled and, if applicable, should also state which supervisory board member (or members), if any, it does not consider to be independent.

NN Group applies this best practice provision.

## Principle

## Implementation by NN Group

- ix. the management board performs activities in respect of culture;
- x. the supervisory board recognises signs from the enterprise affiliated with the company and ensures that any actual or suspected material misconduct and irregularities are reported to the supervisory board without delay;
- xi. the general meeting proceeds in an orderly and efficient manner;
- xii. effective communication with shareholders is assured; and
- xiii. the supervisory board is involved closely, and at an early stage, in any merger or acquisition processes.

The chairman of the supervisory board should consult regularly with the chairman of the management board.

### 2.3.7 Vice-chairman of the supervisory board

The vice-chairman of the supervisory board should deputise for the chairman when the occasion arises.

A management board member should report any potential conflict of interest in a transaction that is of material significance to the company and/or to such management board member to the chairman of the supervisory board and to the other members of the management board without delay. The management board member should provide all relevant information on this subject, including information relevant to the situation regarding his spouse, registered partner or life companion, foster child or relative by blood or marriage up to the second degree.

A supervisory board member should report any potential conflict of interest in a transaction that is of material significance to the company and/or to such supervisory board member to the chairman of the supervisory board without delay and provide all relevant information on this subject, including information relevant to the situation regarding his spouse, registered partner or life companion, foster child or relative by blood or marriage up to the second degree.

If the chairman of the supervisory board has a potential conflict of interest, he must report this to the vice-chairman of the supervisory board without delay.

The supervisory board should decide, outside the presence of the management board member or supervisory board member concerned, whether there is a conflict of interest.

### 2.7.4

#### Accountability regarding transactions: management board and supervisory board members

All transactions in which there are conflicts of interest with management board members or supervisory board members should be agreed on terms that are customary in the market. Decisions to enter into transactions in which there are conflicts of interest with management board members or supervisory board members that are of material significance to the company and/or to the relevant management board members or supervisory board members should require the approval of the supervisory board. Such transactions should be published in the management report, together with a statement of the conflict of interest and a declaration that best practice provisions 2.7.3 and 2.7.4 have been complied with.

NN Group applies this best practice provision. A transaction in which there are conflicts of interest shall be published in the management report, provided that such publication (i) shall not be conflicting with any applicable law or regulations, (ii) shall not be in breach of any applicable confidentiality obligation, and (iii) will not affect its competition position (concurrentiepositie).

**2.7.5 Accountability regarding transactions: majority shareholders**

All transactions between the company and legal or natural persons who hold at least ten per cent of the shares in the company should be agreed on terms that are customary in the market. Decisions to enter into transactions with such persons that are of material significance to the company and/or to such persons should require the approval of the supervisory board. Such transactions should be published in the management report, together with a declaration that best practice provision 2.7.5 has been complied with.

**2.7.6 Personal loans**

The company should not grant its management board members and supervisory board members any personal loans, guarantees or the like unless in the normal course of business and on terms applicable to the personnel as a whole, and after approval of the supervisory board. Loans should not be forgiven.

NN Group applies this best practice provision. Loans that already exist upon appointment as an Executive Board member or Supervisory Board member however, may be continued. Subsidiaries of NN Group may in the normal course of their business and on terms that are customary in the sector, provide other banking and insurance services to Executive Board members and Supervisory Board members without approval of the Supervisory Board.

- iv. the pay ratios within the company and its affiliated enterprise and, if applicable, any changes in these ratios compared to at least five previous financial years;
- v. in the event a management board member receives variable remuneration, how this remuneration contributes to sustainable long-term value creation, the measurable performance criteria determined in advance on which the variable remuneration depends, and the relationship between the remuneration and performance; and
- vi. in the event that a current or former management board member receives a severance payment, the reason for this payment.

NN Group applies this best practice provision.

The information referred to in this best practice provision is included in the remuneration report to the extent such information is not price sensitive (koersgevoelig) and/or competition sensitive. In particular the quantitative elements of the performance criteria may be price sensitive or competition sensitive. For this reason only the parameters, and not the actual targets, are disclosed.

### 3.4.2

#### Agreement of management board member

The main elements of the agreement of a management board member with the company should be published on the company's website in a transparent overview after the agreement has been concluded, and in any event no later than the date of the notice calling the general meeting at which the appointment of the management board member will be proposed.

The report of the general meeting should be made available on request to the shareholders no later than three months after the end of the meeting, after which shareholders should have the opportunity to react to the report in the following three months. #### Voting as deemed fit

Shareholders, including institutional investors (pension funds, insurance companies, investment institutions and asset managers), should exercise their voting rights on an informed basis and as they deem fit. The general meeting of shareholders of a company not having statutory two-tier status ("structuurregime") may adopt a resolution to cancel the binding nature of a nomination for the appointment of a member of the management board or of the supervisory board and/or a resolution to dismiss a member of the management board or of the supervisory board by an absolute majority of the votes cast. It may be provided that this majority should represent a given proportion of the issued capital, which proportion must not be set higher than one-third. If this proportion of the capital is not represented at the meeting, but an absolute majority of the votes cast is in favour of a resolution to cancel the binding nature of a nomination, or to dismiss a board member, a new meeting may be convened at which the resolution may be adopted by an absolute majority of the votes cast, regardless of the proportion of the capital represented at the meeting.

#### Voting right on financing preference shares

The voting right attaching to financing preference shares should be based on the fair value of the capital contribution.
